

## **Public Safety Committee Meeting Minutes**

Meeting called to order by Tim Stocks at 18:30 hours.

#### **Approval of Previous Minutes:**

Phil Rundle moved and Tim Stocks 2<sup>nd</sup> to approve the minutes from the December 10, 2014 meeting, Carried.

#### **Concerned Citizens:**

Barb Krattiger, from the Board of Appeals asked about the Variances for Truck Parking, questioning the need to have persons appear before the Board of Appeals every year to renew the variance. After discussion, Deputy Chief Raupp will check with the City Attorney about other options that were discussed and bring back answers and suggestions to the Public Safety Committee.

Deputy Chief Raupp advised that there are three (3) semi's, that are not complying with the City Parking Ordinance. Deputy Chief Raupp will deliver a letter to the owners/drivers to advise of the possibly of a citation if the ordinance is not complied with.

A complaint was received from David Searles about a "truck running all of the time" at the Wegner parking area off of East 9<sup>th</sup> Ave. Deputy Chief Raupp advised that he had not been able to locate a semi running, but did find a generator running on a semi-tractor at this location. It is

believed that the generator is for the semi purpose and is not in violation of City Ordinances. Information only at this time.

Deputy Chief Raupp advised of some issues with the new revised Ordinance book and that some time will be needed to complete the necessary work to enact them. Hopefully this will be completed by March 2015.

Deputy Chief Raupp advised that he is starting the upgrade of the radio system to digital for the ability to communicate with Rock County. The money for this project has been set aside and has been approved.

Deputy Chief Raupp advised that a grant is being applied for to have a training exercise with Green County Emergency Management in 2016.
