PUBLIC SAFETY COMMITTEE

1. **Call to Order:** Meeting called to order by Chairperson Troy Nyman at 16:30 hours.
2. **Roll Call to determine if a quorum is present:** Committee Members: Troy Nyman, Mary Mason, Jason Coplien, Rich Bennett; all present. Also Present: Deputy Police Chief Brian Raupp and Better Brodhead Representative Kathleen Comeau.
