

Public Safety Committee Minutes
Wednesday, March 6, 2013 4:30pm

Present: Alderman Vickers, Tim Stocks, Police Chief Tom Moczynski, Fire Chief Wayne Gibson, Phil Rundle.

Alderman Vickers called the meeting to order at 4:30pm.

Minutes from the February 6, 2013 meeting were distributed. Rundle made motion to accept, Vickers seconded. Motion to approve minutes carried.

Fire Department:

Chief Gibson reported that the fire department requirements for the July 4th celebrations for 2013 will be the same as those used in 2012.

Police Department:

Truck Route Signage:

Chief Moczynski briefed committee on signage proposal to further define truck route for traffic on 1st Center near the 15th St. intersection. Vickers made motion to approve the planned signage and recommendation to the Public Works Department for their consideration. Rundle seconded. Motion carried.

Licenses and Permits:

Request for a cigarette and tobacco license for Dollar General was reviewed. Stocks made a motion to approve. Rundle seconded. Motion carried.

The following bartender licenses were submitted for review: Tory Elizabeth Fitters, Stop-N-Go; Cory Lee Steinen, Stop-N-Go; Nicole Megan Pember, Stop-N-Go. Rundle made motion to recommend approval, Vickers seconded. Motion carried.

Truck parking ordinance proposals:

Chief Moczynski distributed updated copies of the proposed trucking ordinances that will be presented to the City Council for consideration. (See Attachments A1 thru A7). Motion to approve as presented (Attachment A-1) creating a heavy truck parking lot by Vickers. Seconded by Rundle. Motion carried. Motion to approve ordinance amending Section 10-1-11(h) (Attachments A-2, A-3) by Vickers. Seconded by Gibson. Motion carried. Motion to approve ordinance amending Section 10-1-28 (Attachments A-4, A-5, A-6) by Vickers. Seconded by Gibson. Motion carried. An ordinance amending Section 13-1-124(c)(2) (Attachment A-7) was tabled until a special meeting of the Public Safety Committee scheduled for March 13, 2013, at 2PM to allow for further research by Chief Moczynski.

Building Inspector:

Emergency Management:

Functional Emergency Accident Exercise planned for May 4, 2013. Simulated disaster coordinated with Green County Emergency Management. A full scale exercise is planned to October 2013.
