Licenses and Permits:

Application for Bartender's License: Justin lee Campbell-Brodhead Foods (Piggly Wiggly); Jackie L. Covert, Brodhead Foods; Rebecca Sue Ferraro, Bridges; Daniel Eugene Palan, Brodhead Foods were reviewed. Motion to approve made by Rundle, 2nd by Peterson. Carried. Temporary Class B fermented beverage permit request submitted for the Brodhead Fire District for April 26, 2014 was reviewed. Class A beer and Class A liquor license for Brodhead Foods, Daniel E. Palan was reviewed. Motion to approve both requests made by Rundle Second by Peterson. Motion carried. Hunting permit requests were reviewed for Thomas Jeffery hall and James Daniel Pann. Chief Moczynski noted that going forward all permits for hunting in the Pearl Island area must reflect that no motorized vehicles are allowed. He will ask council to consider rewording permits. Stocks made motion to approve permit requests pending rewording to reflect no motorized vehicles change. Rundle seconded. Carried.

City Land for Use as Police Gun Range:

Officer Brian Raupp briefed and requested committee consideration using some city property in Pearl Island Project (known as Sand Hill) as a gun qualification range. Item tabled until next meeting pending further information.

Trucks on 10th St. Update:

Per suggestion by Rich Vogel, Chief Moczynski recommended that "No Thru Trucks" signs be placed at on E. 10th St. at 1st Center Av., and on E. 2nd Av. between E. 10th and E. 12th Sts. and **elimination of the truck routes on 10th street between 1st center and E 2nd street, and on E 2nd Avenue between 10th and 12th street.** Motion to recommend to council placement of said signs made by Rundle. Second by Peterson. Motion carried.

Speed limit change on 23rd St.:

Item tabled until committee can consider feedback from City Engineer.

Stop signs at frontage road at 25th St.:

Chief Moczynski distributed copies of resolution to install said stop signs. Council has forwarded to City Attorney for approval.

Speed concerns on 4th St. at City swimming Pool:

Committee discussed traffic concerns at this location especially during summer months. Was noted this artery is actually county jurisdiction. Item tabled for further information until next meeting.

Crosswalk on Hwy 11 at 4th Av.:

Item tabled. Area will be monitored to determine if further action is necessary.
