Mayor Pinnow called meeting to order at 7:00 PM. Roll call vote shows all Aldermen present except Alderman Fox.

Mayor Pinnow presented certificates recognizing the Youth in Government representatives and thanked them all for their service. Each student spoke about their experience on Youth in Government.

Public Works: Director Vogel advised council that they are in the process of getting proposals for street projects. He stated that Ash Tree removal is in full swing. Moving forward with SCADA upgrades for the lift stations, the new system will have everything connected. Should be completed early June if everything goes as planned. Working on permit for WWTF due in October for the Phosphorus trading.

Economic Development: Mayor Pinnow stated they will start examining the direction of the committee.

Public Safety: Chief Hughes presented applications for operator licenses for Jon Spencer and Geoffrey Grendble. Public Safety Committee has reviewed and recommends approval. Motion by Huffman to approve the applications as presented. Second by Anderson. Six ayes. Motion carried.

Chief Hughes presented an application for a Street Closure for a Graduation Block Party from East 2nd Avenue from N403 to N401 be closed on Sunday, May 28th from 3pm to 8pm. Chief Hughes presented an application for a Street Closure for the Annual Memorial Day Parade on 12th Street from 1st Center Avenue to East 9th Avenue on May 29, 2017. Chief Hughes presented a public event application for the Wings of Hope Walk for June 10 from 8am to 4pm from Putnam Park to Pearl Island. Public Safety Committee has reviewed all applications and recommends approval. Motion by Anderson to approve the applications as presented. Second by Fox. Six ayes. Motion carried.

Chief Hughes presented an applications for street closure permits with requests for open intoxicants. Public Safety Committee has reviewed and does not recommend a resolution be drafted for this purpose. Discussion by council with no action taken.

Fire District: Alderman Anderson stated they will be burning the garage at the Mandrel Property May 10th or 17th. The fire district with be burning the barn either June 3rd or June 10th depending on the weather. Adding an alternate member to the commission will be discussed at a later meeting.

BID Board: Alderman Huntington stated that Lon Lederman will be stepping down from the committee. Mayor Pinnow reported that cigarette snuffers and barrels are being replaced. A new picnic table has been added to Tinkers Garden on the square. Students will be planting flowers on May 16th.

Senior/Community Center: Mayor Pinnow stated the plans have been drawn up and they are hoping to have price in a few months to begin fundraising.

Historic Preservation: Alderman Huntington stated there is a lack of communication for projects being done.

Plan Commission: Attorney Schroeder presented Ordinance 2017-010 Zoning Classification of property owned by the City of Brodhead Lot 5 and the East 23 Feet of Lot 6 of Block 101 from Light Industrial I-1 to General Commercial C-1. A public hearing was held before the Plan Commission and they have recommended approval. Motion by Fox to approve the ordinance as presented. Second by Anderson. Youth vote four ayes.
