Other Business: Deb reported that Blackhawk Tech Monroe is offering a 4yr degree for Ag and may be looking to businesses in the Ag field to mentor students for employment. Some of the courses students take in high school can count towards this Ag degree.

Rich talked about the possibility of losing the county land fill transfer station and what it would mean to the Brodhead residents and businesses. He reported that Monroe did not sign the contract with the County Waste Management Board.
