

**CITY OF BRODHEAD COMMON COUNCIL MINUTES**  
**MONDAY, JULY 13, 2015**

**Present:** Mayor Pinnow, Alderman Nyman, Hale, Anderson, Bernstein, Rosheisen.  
Deputy Clerk Popanz, City Attorney Mark Schroeder. Absent: Deb Fox

Mayor Pinnow called meeting to order at 7 PM. Roll call vote shows everyone present.

**Minutes:** Motion by Bernstein, to approve minutes of Monday, June 16, 2015, seconded by Hale. All ayes. Motion carries.

Mayor welcomed Mel back.

Audit Committee: No report.

Park Board: Nyman read memo from Park Director who could not be at the meeting tonight. Youth ball will be finishing up in 2 weeks for most leagues and 3 weeks for the midget leagues. Adult softball has 4 weeks left. Adult volleyball is going well. The pool has been operating smoothly. We are in the 2<sup>nd</sup> session of swimming lessons.

Public Works: Moved handicapped parking spot SE corner of Exchange St and Hwy 11. This was the first parking stall east of 1<sup>st</sup> Center Avenue by the entrance to the Bank of Brodhead drive to their ATM machine. This parking stall was moved to the 4<sup>th</sup> parking stall to the East. City Attorney asked if it is marked appropriately and Vogel stated it was. City Attorney Schroeder stated that there should be resolution prepared approving the new location. Motion by Bernstein to have the City Attorney prepare the resolution for the parking stall, seconded by Anderson. All ayes. Motion carries.

Public Works committee made a recommendation to put the 1997 Ford pickup up for sale. Vogel is asking the Council's permission to get sealed bids within the next couple of months. Mayor asked if there could be any benefit for any other department to have that truck. Motion by Nyman to sell the truck with sealed bids, seconded by Hale or use it somewhere else in a City Department. All ayes. Motion carries.

Forestry: no report

Pearl Island: Jerry Elmer reported that they are looking at possibly putting in footings for the bridge. He stated what they are looking at for now is to start the bridge construction. They have more than enough funds to put in the footings. Their thought is to get it started and get renewed interest in the bridge which is phase 1. Phase 2 is more detailed and more costly which would be the steel structure itself. He stated they want to move forward with this and all the engineering has been done on the bridge already. He stated that the donations are quite a bit and we are going to move forward. Public bidding process for the first part would be a smaller amount and they will have two sets of construction documents. Elmer said they are looking for permission to sign a contract with Jim Gersich from Dementia Four to get bids to put the footings in with no cost to the City at this point. Ann asked how much is left to finish this and what would the final cost be about. If you go through the process and you may be able to move forwards in other ways. Elmer stated the cost from Endress Steel for just the structure is \$150,000

just in the steel. He said the total project could probably be around \$450,000.00. He can tell more after the bids come in.

City Attorney asked about the permitting process with DNR. Elmer stated they have suspended that at this time. Motion by Bernstein to allow Pearl Island to proceed with bids, at no costs to the city, for installing abutments, seconded by Hale. All ayes. Motion carried.

**Library Board:** Library Director Busch reported that we had an 18% increase in July of "Items Out". So far for Visits in 2015 the total is 4731 which is a 2% decrease from 2014. Items out is 7056 and E books is 183. The Mayor asked if there was new programs or something helping this increase. Busch stated maybe it is the Super hero theme? She stated they also had a live Boa one day at the Library?

New Library Cards issued were 35. Items added were 275. The VFW room was used 5 times, the small study room 14 times, the program room 3 times and the History room 5 times.

City Attorney Schroeder presented the Ordinance amending Section 455-6A (2) of the City of Brodhead pertaining to Floodplain zoning which was amended to read as follows:

Rock County: Flood Insurance Rate Map (FIRM), panel numbers 55105C0140E and 55105C0255E, all with effective date of September 16, 2015: with corresponding profiles that are based on the Flood Insurance Study (FIS) with effective date of September 16, 2015, volume no. 55105CV001B and 55105CV002B.

Rock County Crosswinds and to the South. Approved the amendment zoning map as proposed. Presented to DNR for comment and they said was consisted also with FEMA. Motion by Bernstein to approve this amendment, seconded by Hale. All ayes. Motion carried.
